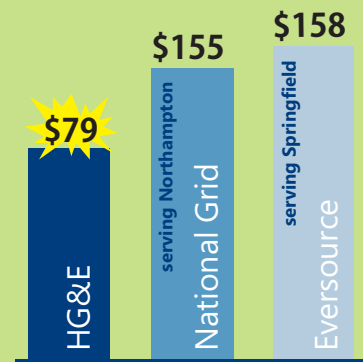

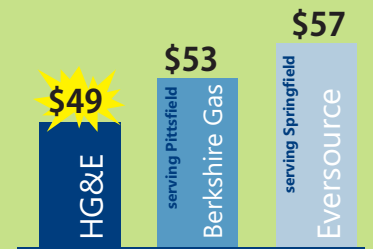
RATE COMPARISONS

HEATING & COOLING WITH ELECTRIC

Air source heat pumps (ASHPs), sometimes referred to as mini-splits, are an energy-efficient electric heating and cooling system that can be used in either part, or all, of your home. Many HG&E customers have decided to move away from oil and propane heating systems in order to install this modern equipment that will both heat and cool a home with a single system. See below to learn more about the benefits of an ASHP system and financial incentives that are available.



1 Lower Greenhouse Gas Emissions

An air source heat pump system can help customers lower their carbon footprint and reduce heating systems emissions as compared to propane, oil, natural gas, and electric resistance equipment.



2 Competitive Cost

Save money on your heating and cooling bills by installing an Air Source Heat Pump compared with propane, oil, or electric resistance. While the initial installation costs can be higher, over the lifetime of the system customers can save up to \$40,000. Please visit hged.com/ashp to see the estimated lifetime cost comparisons.



3 All-in-one Comfort

For your comfort, air source heat pump technology allows you to heat, cool, and dehumidify your home with a single system. In addition, the systems can allow you to heat and cool individual rooms rather than an entire house.



4 Versatile

Depending on the current layout of your space, customers can design systems with or without ductwork to heat and cool individual spaces or a whole home. Many customers opt to install one unit in order to determine their comfort in using the technology more widely within a home.

AIR SOURCE HEAT PUMP INCENTIVES & RESOURCES

HG&E Basic Heat Pump Rebate: Receive up to \$250/ton (ton = 12,000 BTUs) for installing a qualifying heat pump or mini-split.

HG&E Whole Home Heat Pump Program: This program offers a higher heat pump/mini-split rebate of \$600-\$750/ton as well as a weatherization rebate adder for installing a qualifying heat pump or mini-split system that is sized to meet 100% of your home's heating requirements.

HG&E Residential Energy Conservation Program: Financial assistance at 0% interest up to \$10,000 for qualifying projects. Please apply before you begin your project to secure the funds.

Mitsubishi Muni Heat Pump Discount: Receive a \$300-\$600 discount off the purchase of a qualifying heat pump or mini-split installed by a Mitsubishi Diamond Contractor.

Connected Homes Smart Device Monthly Incentive: Receive a \$5-\$8/month incentive for allowing HG&E to remotely adjust the temperature of heat pump or mini-split system a few times each month (must have qualifying thermostat or heat pump controller).
