

2025-2026 Budget Program

Holyoke Gas & Electric's (HG&E) Budget Program makes it easier for customers to manage energy costs throughout the year by dividing bills into 12 equal monthly payments. This year, plan ahead and avoid those high winter bills by joining HG&E's Budget Program!

Signing up is easy! Just fill out the form on the back of this page and we will send you your monthly payment amount. The estimated monthly payment is determined from previous utility bills. The estimated cost is then divided into 12 equal monthly payments, to start with the June billing. Your budget payment amount will be reviewed after the January cycle, and will then be adjusted up or down as necessary.

The Budget Program is available to all HG&E customers (commercial and residential) at no additional cost. Please note, your account must have a \$0 balance, and your location must have one year of billing history in order to enroll in the program. If you are currently participating in the budget program, you do not need to re-enroll.
