### Summer energy saving tips:

- ▶ Close shades, drapes, and blinds during the day.
- ▶ Use a microwave instead of the range/oven.
- During mild weather, use fans instead of air conditioning.
- ▶ Clean and replace air conditioner filters every two weeks during the summer.
- Plant shade trees around your home to reduce air conditioning costs.
- ▶ Keep a 2-3 foot clearance around air conditioning units to ensure proper circulation and optimum efficiency.

### **Important Customer Notice: Gas Meter Inspection**
